

DIRECTIONS TO MARLTON

FROM BENJAMINE FRANKLIN BRIDGE

After crossing the Benjamin Franklin Bridge, follow Route 30 (Admiral Wilson Boulevard) and bear left onto Route 70 / Route 38 exit ramp. Follow signs for Route 70 East (Cherry Hill). Stay on Route 70 East approximately 6 miles past the Garden State Shopping Center and past Route 295 to the Marlton Circle (now under construction – landmark *Olga's Diner*, which is now closed). Bear right onto Route 73 South from Route 70 East. Proceed through intersection of Route 73 South and Evesham Road (*Bradley's Funeral Home*) to the next traffic light - Route 73 South and Ardsley Avenue (landmarks – *Anne Sez, Bed, Bath & Beyond, Old Navy, Famous Footwear*, and *Genuardi's*). Make a left onto Ardsley Avenue, then the second right into the *Willow Ridge Executive Center*. The law offices of Subranni Zauber, L.L.C. are located in building numbered "3", located in the far lefthand rear corner of the Willow Ridge Executive Office Park complex.

FROM THE BESTY ROSS/TACONY PALMYRA BRIDGE

After the Bridge, follow Route 73 South for approximately 6 miles through Maple Shade and Mt. Laurel into Marlton. Proceed through the Marlton Circle (now under construction - landmark *Olga's Diner*, which is now closed). Proceed through intersection of Route 73 South and Evesham Road (*Bradley's Funeral Home*) to the next traffic light - Route 73 South and Ardsley Avenue (landmarks – *Anne Sez, Bed, Bath & Beyond, Old Navy, Famous Footwear*, and *Genuardi's*). Make a left onto Ardsley Avenue, then the second right into the *Willow Ridge Executive Center*. The law offices of Subranni Zauber, L.L.C. are located in building numbered "3", located in the far lefthand rear corner of the Willow Ridge Executive Office Park complex.

FROM THE WALT WHITMAN BRIDGE

When the road divides on the New Jersey side, follow signs for Route 42 and 295. Take exit thereafter to proceed on Interstate 295 North. Follow 295 North to Exit 34A (Marlton / Route 70 East). Follow Route 70 East to the Marlton Circle (now under construction w/ landmark *Olga's Diner*, which is now closed). Bear right onto Route 73 South from Route 70. Proceed through intersection of Route 73 South and Evesham Road (*Bradley's Funeral Home*) to the next traffic light - Route 73 South and Ardsley Avenue (landmarks – *Anne Sez, Bed, Bath & Beyond, Old Navy, Famous Footwear*, and *Genuardi's*). Make a left onto Ardsley Avenue, then the second right into the *Willow Ridge Executive Center*. The law offices of Subranni Zauber, L.L.C. are located in building numbered "3", located in the far lefthand rear corner of the Willow Ridge Executive Office Park complex.

FROM NEW JERSEY TURNPIKE

Get off at Exit 4 and follow signs for Route 73 South / Marlton. Follow Route 73 South proceeding through the Marlton Circle (now under construction w/ landmark *Olga's Diner*, which is now closed). Proceed through intersection of Route 73 South and Evesham Road (*Bradley's Funeral Home*) to the next traffic light - Route 73 South and Ardsley Avenue (landmarks – *Anne Sez, Bed, Bath & Beyond, Old Navy, Famous Footwear*, and *Genuardi's*). Make a left onto Ardsley Avenue, then the second right into the *Willow Ridge Executive Center*. The law offices of Subranni Zauber, L.L.C. are located in building numbered "3", located in the far lefthand rear corner of the Willow Ridge Executive Office Park complex.

FROM ATLANTIC CITY AND SHORE POINTS

Take the Atlantic City Expressway to Exit 31 – Winslow, Route 73 North. Follow 73 North for about 7 miles (approximately a 20 to 30 minute drive from the exit). At the intersection of Route 73 North and Ardsley Avenue (*Target* to the left, and *Bed, Bath & Beyond, Old Navy, Famous Footwear* and *Genuardi's* to the right) make a right onto Ardsley Avenue, then the second right into *Willow Ridge Executive Center*.
